Climate Catalyst Contest Official Rules

1. HERE'S HOW IT WORKS: Conservation Consultants, Inc. (“CCI”) is the Sponsor of this contest. CCI is running our first Home Energy Showcase, see <https://getenergysmarter.org/showcase>. CCI would like to get your help in promoting the Home Energy Showcase, whether or not you are participating in the Showcase. Compete to earn the title of “Climate Catalyst” by promoting the Showcase as described herein and referring the most additional new people to participate in our Home Energy Showcase as “Participants”. The people who are named by the most new Home Energy Showcase Participants as their referrer will be recognized by CCI as the “Climate Catalysts” for 2019 and awarded prizes. See details below. Then start spreading the word amongst your friends and network!

2. CONTEST PERIOD AND TIMELINE: Catalysts may register to promote the Home Energy Showcase online starting on or about August 21, 2019 and ending on October 30, 2019. The last day for Participants to sign up for the Home Energy Showcase is October 30, 2019. Referrals noted in the Showcase registration materials will be matched up with Catalysts participating in this contest and then tallied up. CCI will contact winners by November 11, 2019.

3. ELIGIBILITY: The Climate Catalyst promotion is open only to those who register to participate as set forth in Paragraph 1 and 2 above and who are at least 18 years of age or older as of the date of entry. Open only to legal residents of Allegheny County, Pennsylvania, in the United States. Our employees and our corporate directors and their immediate family members are not eligible. This contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

4. DETERMINATION OF WINNERS: In the process of signing up for the Home Energy Showcase, Participants will be asked to name the person who referred them to participate in the Showcase (if any). Each Home Energy Showcase Participant who names a registered Catalyst will be counted towards the total number of Participants referred by that Catalyst for purposes of this competition. In cases where more than one registered Catalyst share the same, or similar, names, CCI, at its sole discretion, will reach out to the Home Energy Showcase Participant and/or the Catalysts to determine the correct Catalyst to associate with the Participant. CCI will determine the winner of the first and second prizes and, subject to verification, announce the winners by November 11, 2019.

5. PRIZES: The people who are named by the most new, eligible Home Energy Showcase Participants as their referrer will be recognized by CCI as the “Climate Catalysts” for 2019. The Climate Catalyst named by the most eligible Participants as their referrer will be awarded a first prize of \$250.00. The Climate Catalyst named by the second most Participants as their referrer will be awarded a second prize of \$100. Taxes on prizes are the sole responsibility of winners. Prizes are nontransferable and cannot be substituted, or exchanged. Winners of the Climate Catalyst awards will be notified by phone and email by Nov 11, 2019, and awarded the recognition and prizes on Nov 14, 2019 during CCI quarterly

fundraising event, to be specified at <https://getenergysmarter.org/events>. Winners can attend this fundraising without purchasing a ticket. Where permitted by law, winners grant to CCI, and those acting on CCI's behalf, the right to publish their name when announcing the prize.
